Here are a few recent snapshots of life at Mount St. Joseph!





The little ones sang nursery rhymes, performed their abc's in sign language, and participated in an interactive story book. ABLE Families

In observance of Black History Month in February, Marlene Spaulding, Executive Director of ABL Families in Kermit, WV, chose the book, "Who Was Rosa Parks" for their Roll & Read station during Dr. Seuss Literacy and Math Night. "Rosa Parks' refusal to move to the back of the bus was such a key moment for combating racial segregation that I saw this night as an opportunity to share the inclusive love that the congregation has nurtured in me for so many years," she said. ABL Families is a member of our Mission Network and is dedicated to empowering families caught in the net of poverty in the rural Tug Valley area of northern Mingo County. Their mission is to confront the systemic causes of poverty by supporting low-income families as they make positive changes in their lives. ABL is an acronym for Affirming, Believing, Learning and Empowering.

Wheeling Hospital

When Wheeling Hospital wanted to expand their free employee vegetable garden recently, Sister Mary Ann Rosenbaum, who serves as Director of Pastoral Care at the Hospital, had an idea. With her encouragement, the congregation offered space on the grounds at Mount St. Joseph and some financial support for the expansion. The garden (right) was constructed and planted this spring, and when ready, the vegetables will be harvested and taken to the hospital to be made available to employees. Sister Molly Retires from Sisters Health Foundation



For over 25 years, the Sisters Health Foundation has been listening to and collaborating with neighbors, colleagues, and area non-profits to respond to the healthcare needs of the Mid-Ohio Valley community. For 19 of those years, Sister Molly Bauer helped fulfill this mission.

Earlier this year, Sister Molly announced she would retire from the foundation and her position as Senior Program Officer in June.

Sister Molly came to the foundation in 2004 to serve as Health Ministry Initiative Program Director. In this role, she shepherded the establishment of new health ministries in faith-based congregations, and supported the growth and development of existing ministries.

When the Health Ministry Initiative concluded, Sister Molly transitioned into the role of Program Officer in 2013, and to Senior Program Officer in 2017 where she led the creation of the Basic Needs/Direct Service Program which places a priority on the basic needs of vulnerable populations.



A retirement party was held for Sister Molly on June 22 where she celebrated with colleagues, sisters, friends, and leaders of some of the ministries she and the foundation have worked with.
